1. Call to Order

4. Consent Calendar

A. Update, Retaining Wall Project - Nkala/D'Angelo

Civil Engineer, Blaise D'Angelo informed the Board of Directors that the District was nearing the final stages of the permitting process with the T.R.P.A..

Civil Engineer, Blaise D'Angelo spoke about the progress of the project, stating that District Grounds Foreman, Jeff Hobby was doing an excellent job preparing the site with bmp's.

Civil Engineer, Blaise D'Angelo also expressed to the Board of Directors that the T.R.P.A. agents spoke about maintenance duties that the District would have to do annually, one item would be cleaning of the drains, the maintenance duties will be outlined in the permit.

District Ground Foreman, Jeff Hobby informed the Board of Directors that he has all the equipment needed, as well as dirt, and gravel, and is ready to start the project as soon as the District receives the permit.

Discussion, and approval, increase in-ground cremation package, service charges document -

District Manager, Adria Nkala presented to the Board of Directors a staff report proposing an increase to the in-ground cremation package on the charges for current services document, a copy of the charges for current services document, a copy of the charges for current services document, a copy of the charges for current services document detailing the proposed increase, and a California Cemetery Services comparison document created from information taken from the California Association of Public Cemeteries.

The District Manager, Adria Nkala expressed to the Board of Directors that after reviewing the California Association of Public Cemeteries service comparison document that comes out every year it appeared that the District is priced below industry standard.

After discussion, the Board of Directors voted to change the price on the lot only in the in-ground cremation packet, which would bring the total price of the in-ground cremation packet from \$1854.00 to \$2460.00 effective July 19, 2022. (Stanton/Eymann: Unanimous)
